

Section 2. CHARTER MEMBER. A charter member shall be any person in good and regular standing in the Christian Reformed Church who contributes the amount of \$2.50 to this corporation prior to the time that the official constitution is adopted.

Section 3. ASSOCIATE MEMBER. An associate member shall be every member of the Christian Reformed Church who is in good and regular standing with the Christian Reformed Church and who contributes \$5.00 or more annually and shall be entitled to voting privileges.

Section 4. PATRON MEMBER. A patron member is any regular member who voluntarily agrees to pay \$10.00 annually above the regular contributions into the general treasury, and who voluntarily signifies his or her willingness to be contacted by the Central Board whenever a financial emergency arises. A patron member ceases to be such when he or she chooses not to pay the annual \$10.00 referred to above.

#### ARTICLE 5.

Section 1. ASSETS. Said corporation is organized on a non stock basis.
